All purchase orders must show Deere & Company as the vendor and reference the contract number.

Fees	<b>Delivery Charge</b> Optional delivery charge of \$8 per loaded mile is allowed for the delivering dealer. Use <a href="Google-Maps">Google-Maps</a> to calculate the mileage.

Financing	John Deere Municipal Lease by John Deere Financial Allowed: If the agency rules and guidelines allow. This 12-60-month financial product requir payments and enables ownership of the equipment.
	<b>Government Operating Lease by John Deere Financial Allowed:</b> If the agency rules and guidelines allow. This 24-60-month product requires payments and the equipment is returned to the dealer location at the end of the term.
	Retail Note Financing by John Deere Financial or Third Party Allowed: If the agency rules and guidelines allow.
