All purchase orders must show Deere & Company as the vendor and reference the contract number.

Delivery Obligations	None.			
Fees	A delivery fee of \$4.00 per loaded mile is allowed. This fee is <u>not</u> per machine; it's per load. This fee should be shown separately on the quote or purchase order. Miles are to be calculated sing <u>Google Maps</u> . Dealers have the option to charge customers 4% of the equipment contract sale for set-up for golf products only (reel mowers-G10, special application mowers-G15, special application vehicles-G20, aeration-G25, debris maintenance-G30, golf fleet management-G35). The 4% set-up is in lieu of any/all Government Sales reimbursement for set-up. This fee should be shown separately on the quote or purchase order.
