Purchase Order Processing

Procedures for ordering and processing and completing sale and Delivery

Once the purchase order has been received by Keil Equipment the following occurs:

1. The purchase order is entered into Keil Equipment system. Keil Equipment will send a confirmation to the customer indicating all equipment being ordered, and the delivering dealer information. Confirmation is mailed to the customer.
2. Equipment not in dealer inventory has to be ordered by the dealer. After the dealer places the order, the order number needs to be included on the Contract Quote Worksheet or agency Purchase Order. If equipment is in dealer inventory, the invoice number needs to be included on the Contract Quote Worksheet or Purchase Order.
3. Equipment used to complete Keil Equipment contract sale will be tagged with the GNS order number in the customer order field. Once equipment has been tagged for a Keil Equipment sale, it must be used to fulfill the sale.

4. Do not settle for the equipment. Settlement will be automatically processed 15 calendar days after the last piece of equipment on the order has been invoiced by the factory. Or if the machine is in stock 15 days after the PO has been received from Keil Equipment.
5. Special processing procedure for ROTARY CUTTERS: If you desire to use a rotary cutter that has been ordered under the Early Order Program, you must settle off the cutter, claim the applicable bonus and put it into paid for goods, then notify Keil Equipment that you have done so and provide invoice number. GNS will then settle it out of paid for and issue your credit.
6. If a trade is part of the purchase order; include that on your quote and also on the purchase order. When the auto settlement occurs, the debit/credit memo will list the "trade value" amount. This is the maximum amount you may floor plan. You will need to do a "Floor Plan Only" in JDSET. In the comment section, please indicate this is for a Keil Equipment Sale and reference the GNS settlement number.
7. The dealer is responsible for registering the warranty and obtaining a signed delivery receipt. The Delivery Receipt must be faxed to Keil Equipment @518-537-5276 after customer delivery.
8. Direct Governmental and National Account sales are posted to the delivering dealer's sales records.
9. **Do not invoice or accept payment from the customer**. Payments should be made to: Kiel Equipment Co.,Inc. 2356 Rt. 9 Hudson NY 12534

Internally within John Deere we are assisting Keil Equipment by allowing the local dealer to work with Keil Equipment to quote, sell, order the equipment or use dealer inventory and deliver the equipment receiving a signed delivery receipt from the customer once it has been delivered. **John Deere will then settle the equipment off the local dealer's statement issuing the standard 10% credit on tractors and 8% on attachments + standard set up credit.** Once the settlement has been completed we will then transfer the equipment invoices to Keil Equipment who is responsible for invoicing the agency and collection of payments.

Finally, the New York State Office of General Services provided a [Purchasing Memorandum](#) confirming the arrangement with Keil Equipment
