Allied (non-Deere)	Allowed, can be sold with a contract item. Allied items are products, implements, attachments, accessories, parts or bundles not manufactured by John Deere that are requested by the customer to complete the purchase of John Deere equipment awarded on contract.
Credit Cards	Allowed.

Special Delivery Obligations	FOB Destination, Freight Prepaid and Allowed (freight already included in discount).
