- E. Where permitted by law, neither John Deere nor any company affiliated with it makes any express or implied warranties, representations, conditions or promises, other than those set forth herein, as to the quality, performance or freedom from defect of John Deere parts, and NO STATUTORY OR IMPLIED WARRANTY OR CONDITION OF MERCHANTABILITY OR FITNESS IS MADE.
- F. THE DEALER HAS NO AUTHORITY TO MAKE ANY REPRESENTATION OR PROMISE OR ADMISSION ON BEHALF OF JOHN DEERE OR TO MODIFY THE TERMS OR LIMITATION OF THIS WARRANTY IN ANY WAY. THE DEALER IS NOT AN AGENT OF JOHN DEERE.
- G. The only remedies the customer has in connection with the breach or performance of any warranty on John Deere parts are those set forth in these warranty conditions or specified by statute, regulation and not capable of exclusion by Condition C above. In no event will Dealer, John Deere, or any company affiliated with John Deere be liable for incidental or consequential damages or injuries, including but not limited to loss of crops, loss of profits, rental of substitute equipment or other commercial loss.
