You're no longer out of luck when it comes to your out-of-warranty equipment with a Used PowerGard Protection Plan¹ from John Deere. Designed to preserve the performance and reliability of aging equipment, our new plan option now provides limited engine-and-powertrain coverage on out-of-warranty, customer-owned units which include tractors, combines, sprayers, self-propelled forage harvesters, cotton harvesters and nutrient applicators.

To be eligible for Used PowerGard, your out-of-warranty equipment must pass a 100-plus point inspection and fluid sample testing by a John Deere dealer. Customer-owned machines that qualify include:

- **Tractors:** up to 10 years old and up to 5,000 hours
- **Combines, Sprayers, SPFHs, Cotton Harvesters & Nutrient Applicators:** up to 7 years old and up to 2,000 hours

Similarly, Used PowerGard Extended Warranty Plans are also still available to you when purchasing used equipment from a John Deere dealer.

Used PowerGard² offers exceptional benefits, such as:

■ Peace of mind

Know your machine is in good hands due to the expertise of your local John Deere dealer who will inspect, repair and fluid sample your unit.

■ Choose your terms

Select from a variety of flexible term lengths, in total months and total hours. Choose the terms that fit your individual needs, depending on how long you plan to own your machine and your estimated annual usage hours.

■ No pre-approval of claims necessary

Call or visit any authorized John Deere dealership for service.

■ Repaired with genuine John Deere parts

Highly-trained dealer technicians will fix it right, using exactly the right Genuine John Deere parts to fit your machine.

Any remaining PowerGard coverage is fully transferable to a new owner, with no transfer fee.
