Contract Details

Delivery Obligations	At the time of delivery, the dealer must provide operational, safety and maintenance training on the equipment at no additional charge.
Fees	Delivery Charge An optional delivery charge of \$8 per loaded mile is allowed for the delivering dealer. This fee is <u>not</u> per machine; it's per load. If charged, the fee must appear on the quote or purchase order. Use Google Maps to calculate the mileage.
Financing	Not Allowed. Contract prohibits financing.
Machine Hours	Not Allowed: Due to factory delivery, pre-delivery inspection, machine setup and installation of attachments, machines may have minimal hours. Machines designated as demos are not allowed.
Manuals	Each delivery of equipment must include: a minimum of one (1) printed copies of the manufacturer Owner's/Operation Manual, Service Manual, Parts Manual, Manufacturer Warranty, and a minimum of two (2) ignition keys. Digital copies are acceptable. Dealer will be reimbursed for manuals listed on the quote.
