

IOWA - Construction, Agricultural and Ground Maintenance Equipment Contract

Eligibility:	<p>This contract is extended to all state agencies and political subdivisions (counties, cities, schools, etc.) of Iowa. Iowa has also extended this contract to the states surrounding Iowa (IL, KS, MN, MO, NE, SD, WI). Private schools (K-12) and private universities are not considered political subdivisions and therefore, can't utilize this contract.</p> <p>Iowa state agencies are not allowed to use cooperative contracts (ex. BuyBoard, Sourcewell, HGAC, NPP) without the existence of a Participating Addendum (PA) with the State. Therefore, cooperative contracts may not be offered as an alternative contract without a PA. Iowa political subdivisions may use cooperative contracts if the contract allows it and the political subdivision's rules and guidelines allow it.</p>
