

IOWA - Construction, Agricultural and Ground Maintenance Equipment Contract

Contract Period:	February 8, 2017 – February 7, 2022
Eligibility:	<p>This contract is extended to all state agencies and political subdivisions (counties, cities, schools, etc.) of Iowa. Iowa has also extended this contract to Illinois and Minnesota. Private schools (K-12) and private universities are not considered political subdivisions and therefore, can't utilize this contract.</p> <p>Iowa state agencies are not allowed to use cooperative contracts (ex. BuyBoard, Sourcewell, HGAC, NPP) without the existence of a Participating Addendum (PA) with the State. Therefore, cooperative contracts may not be offered as an alternative contract without a PA. Iowa political subdivisions may use cooperative contracts if the contract allows it and the political subdivision's rules and guidelines allow it.</p>
