The first invoice shall be dated on or before June 30th; the second invoice shall be dated on or about November 30th at the conclusion of the leasing period.</p> <p><b><u>Tractor Specifications</u></b></p> <p>Rental rates and tractor models are detailed in the Price Structure below.</p> <ul style="list-style-type: none"> <li>• Minimum Specifications: <ul style="list-style-type: none"> <li>○ Tractors shall be an agricultural-type and will be used for highway mowing. The tire configurations and any other options offered with the tractors shall be appropriate for this work application.</li> <li>○ Engine horsepower shall be a range of 100 to 150, inclusive.</li> <li>○ Tractors offered shall be new production models with less than 50 engine hours.</li> <li>○ Shall include a manufacturer’s standard all-weather cab including heater, defroster, air conditioning and the capability to circulate fresh air or cab air only.</li> <li>○ Shall include a minimum of three (3), heavy-duty, rear-mounted, remote hydraulic outlets, designed to provide flow and pressure to operate flex-wing style mowers.</li> <li>○ Shall include a mechanical or hydraulic front wheel assist.</li> <li>○ Shall be capable of operating 540 and/or 1000 RPM power take-offs (PTO).</li> <li>○ The three-point hitch provided shall be capable to connect Category II and Category III pins and shall include rigid sway bars. <b>Note:</b> The three-point hitch components will be used at limited locations.
