All purchase orders must show Deere & Company as the vendor and reference the contract number.

Delivery Obligations	None.
Fees	None.
Financing	Not allowed. Contract prohibits financing.
Machine Hours	Allowed: Due to factory delivery, pre-delivery inspection, machine setup and installation of attachments, machines may have hours but should not exceed hour usage guidelines in the warranty administration manual.
Manuals	An operator's manual is included with the delivery of the equipment at no charge.



Miscellaneous	Agencies will receive an additional 1% discount off MSRP on Ag Tractors (5000-9000 Series) if the agency picks up the tractor at the nearest dealer location instead of having it delivered. The quote or purchase order must show "customer pick-up" if the agency chooses to pick-up the tractor.		
Multiple Unit Discount	Sales of 3 or more like self-propelled products sold on the same purchase order are eligible for the multi-unit discount.
