All gas or diesel units must have a full tank of fuel at time of delivery.</p> <p>Remove all dealer identification or dealer advertising from the equipment prior to delivery. The vendor shall also service and adjust the equipment to include as a minimum the following:</p> <ul style="list-style-type: none"> • Focusing of lights. • Tuning of engine. • Adjustment of accessories. • Checking of electrical, braking and suspension systems.
