Quotes	Quotes are provided by John Deere Government Sales and are valid for 30 days.
Allied (non-Deere)	Allowed, equipment may be sold in connection with the sale of a contract item, not to exceed \$5,000 or local entity's max threshold for the order. Allied items are products, implements, attachments, accessories, parts or bundles not manufactured by John Deere that are requested by the customer to complete the purchase of John Deere equipment awarded on contract.
