#### **Quotes and Purchase Orders:**

Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local John Deere Dealer. Submit your purchase order to your dealer. The John Deere Dealer will submit the purchase order to John Deere's Government Sales office.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

### **Contract Details**

Delivery Obligations	One copy of a parts CD and technical manual CD must be provided to the customer at no cost. Manuals must be included on the quote or the agency's PO. Dealer will be reimbursed.  Agency may purchase additional manuals directly from the dealer.
Fees	A \$8 per loaded mile delivery charge is allowed and is optional. The charge should be clearly indicated on the agency's purchase order.
	Mileage distance will be the distance from the delivery starting point to the customer's delivery point ONLY. <b>Mileages should be calculated using Google Maps</b> . The ordering agency may use the dealer for delivery, may pick-up the equipment or may contract for delivery with anyone it chooses.



Financing	No financing or leasing allowed.			
Machine Hours	Allowed: Due to factory delivery, pre-delivery inspection, machine setup and installation of attachments, machines may have hours but should not exceed hour usage guidelines in the warranty administration manual.			
Manuals	An operator's manual is included with the delivery of the equipment at no charge.

	Agency may purchase additional manuals directly from the dealer.			
Miscellaneous	None.			
Multiple Unit Discount	Sales of 3 or more like self-propelled products sold on the same purchase order are eligible for the multi-unit discount. The 3 or more self-propelled products must be in the same equipment categories as shown below and included on the same purchase order. Compatible implements sold with such products also qualify for the multi-unit discount, but do not count as a unit.  Frontier Equipment is excluded from the multiple unit discount.

Open Market by John Deere (listed in the price book)	Allowed with restrictions. State and local agencies may purchase incidental miscellaneous parts, accessories and labor that are directly related to a specific item included on the contract. These types of items may not exceed \$5,000 for an individual purchase order. Total incidentals allowed on a single purchase order as Open Market (items listed in price book and not listed in price book) is \$5,000. Items must be clearly labeled on the purchase order or quote as Open Market.			
	These Open-Market items are <b>implements</b> , <b>attachments</b> , <b>accessories</b> , <b>parts</b> and <b>bundles</b> that are not currently on contract, but are requested by the customer to complete the purchase of John Deere equipment awarded on contract.			



Open Market by Dealer (not listed in the price book)	Allowed with restrictions. State and local agencies may purchase incidental miscellaneous parts, accessories and labor that are directly related to a specific item included on the contract. These types of items may not exceed \$5,000 for an individual purchase order. Total incidentals allowed on a single purchase order as Open Market (items listed in price book and not listed in price book) is \$5,000. Items must be clearly labeled on the purchase order or quote as Open Market.  These are Open-Market items not available from John Deere but offered by the delivering Dealer to complete the purchase of John Deere equipment awarded on contract.

**Allowed:** Items must be clearly labeled on the purchase order or quote as Trade-In. The agency and the dealer will determine the trade-in value.

State agencies must obtain approval from the Department of Administration and must follow the requirements for liquidation of surplus goods. CPV Members are solely responsible for compliance with their local government's requirements for liquidation of surplus goods.
