Contract Period:	May 16, 2023 – June 30, 2024
Eligibility:	<p>This is a multiple award contract for use by ODOT.</p> <p>This contract can be extended to any non-DOT agency (county, township, park district, port authority, transit authority, airport authority, water & sewer district, university/college, etc.) if use of the contract adheres to the agency's own regulations <u>and the non-DOT agency has obtained authorization</u> to participate in the co-op purchasing program. Authorization can be obtained by submitting a request to the Cooperative Purchasing Program - Ohio Department of Transportation. <u>Agencies should provide their authorization to the John Deere dealer.</u></p>

Quotes and Purchase Orders:

Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local **John Deere Dealer**. **Submit your purchase order and your [authorization to use the co-op program \(for non-DOT agencies only\)](#) to the dealer.**

The John Deere Dealer will submit the purchase order and authorization letter (if applicable), to John Deere's Government Sales office.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

Delivery Obligations	Tractors must be delivered with a full tank of fuel and diesel exhaust fluid if applicable.
Fees	None.
Financing	<u>John Deere Municipal Lease by John Deere Financial</u> Allowed: For non-state agencies only , if their rules and guidelines allow. This 12-60 month financial product requires payments and enables ownership of the equipment.

	<p><u>Government Operating Lease by John Deere Financial</u> Allowed: For non-state agencies only, if their rules and guidelines allow. This 24-60 month product requires payments and the equipment is returned to the dealer location at the end of the term.</p> <p><u>Retail Note Financing by John Deere Financial or Third Party</u> Allowed: For non-state agencies only, if their rules and guidelines allow.</p>

The Extended Warranty must be registered by the selling dealer for the plan to be activated.</p> <p>Agencies can "build" their own 5060E, 5100E, 5105M, 6120E and 6110M tractor configurations using the price pages linked below. The appropriate contract discount will be applied <u>to the total list price</u> of the new configuration. Extended warranty for these tractors must be purchased as an Open Market item and must be listed on the quote and/or PO as "open-market".</p> <p>Agencies can also purchase any of the other 5000-7000 Series tractor models shown in the linked price pages. The appropriate contract discount will be applied <u>to the total list price</u> of the tractor.
