The line-item pricing shown below for the 5060E, 5100E, 5105M, 6120E, and 6M 115 includes a MANDATORY 3 Year/36 Month/1500 Hour Full Machine Warranty and the deductible. Please note the Extended Warranty as a separate line item with no cost on the agency's quote and/or PO. The Extended Warranty must be registered by the selling dealer for the plan to be activated. Agencies can "build" their own 5060E, 5100E, 5105M, 6120E and 6M 115 tractor configurations using the price pages linked below. The appropriate contract discount will be applied to the total list price of the new configuration. Extended warranty for these tractors must be purchased as an Open Market item and must be listed on the quote and/or PO as "open-market".
