Quotes	Quotes are valid for 30 days from the creation date of the quote <b>OR</b> until the contract expires, <u>whichever</u> <u>occurs first</u> . All quotes created in JDQ2 have creation and expiration dates on the upper right hand corner of the first quote page for your convenience.

Credit Cards	Allowed.
Demo	Allowed as long as agency agrees and the equipment still qualifies for full warranty per John Deere's Warranty Administration Manual.
Fees	None.
Financing	Allowed for <u>non-state agencies only</u> , if their rules and guidelines allow it. Agencies may use the John Deere Municipal Lease for financing or their own third-party financing entity. The low interest rate, low cost John Deere Municipal Lease, is a type of financing that is specifically designed for qualified state, government, and educational entities which <b>allow full ownership at the end of the lease term</b> .

The Administrator of the Office of Equipment Management reserves the right to reject or refuse any trade-in allowances offered if it is determined by ODOT that refusal will be in ODOT's best interest.
