Eligibility:	This is a multiple award contract for use by ODOT.
	This contract can be extended to any local, county or state governmental agency, if ODOT has authorized the agency to use the contract and use of the contract adheres to the agency's own regulations. Non-DOT agencies can obtain an authorization email from ODOT by contacting Nicholas Krafft at the ODOT Office of Contracts (Nicholas.Krafft@dot.ohio.gov). Agencies should provide the authorization email from ODOT to the John Deere dealer.

Quotes and Purchase Orders:

Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local John Deere Dealer. **Submit your** purchase order and your authorization letter from **ODOT** (for non-**ODOT** agencies) to the dealer.

The John Deere Dealer will submit the purchase order and authorization letter (if applicable), to John Deere's Government Sales office.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

Delivery Obligations	Units must be delivered with a full tank of fuel.

This 12-60 month financial product require payments and enables ownership of the equipment. This 24-60 month product requires payments and the equipment is returned to the dealer location at the end of the term. Agencies can also select mower options different from the line-item options priced below and "build" their own configurations using the price pages linked below. The discount will be applied to the total list price of the new configuration.
