

OHIO - Department of Transportation (ODOT) Mowing Attachments, Boom Mowers & Zero Turn Mowers Contract

Contract Number:	208-23
Contract Period:	February 7, 2023 – February 29, 2024
Eligibility:	This is a multiple award contract for use by ODOT. This contract can be extended to any non-DOT agency (county, township, park district, port authority, transit authority, airport authority, water & sewer district, university/college, etc.) if use of the contract adheres to the agency's own regulations and the non-DOT agency has obtained authorization to participate in the co-op purchasing program. Authorization can be obtained by submitting a request to the Cooperative Purchasing Program - Ohio Department of Transportation (middle of page). Agencies should provide their authorization to the John Deere dealer.

Quotes and Purchase Orders:

Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local John Deere Dealer. Submit your purchase order and your authorization to use the co-op program (for non-DOT agencies only) to the dealer.

The John Deere Dealer will submit the purchase order and authorization letter (if applicable), to John Deere's Government Sales office.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

Delivery Obligations	Units must be delivered with a full tank of fuel.

Financing	John Deere Municipal Lease by John Deere Financial Allowed: For non-state agencies only, if their rules and guidelines allow. This 12-60 month financial product require payments and enables ownership of the equipment. Government Operating Lease by John Deere Financial Allowed: For non-state agencies only, if their rules and guidelines allow. This 24-60 month product requires payments and the equipment is returned to the dealer location at the end of the term. Retail Note Financing by John Deere Financial or Third Party Allowed: For non-state agencies only, if their rules and guidelines allow.
Machine Hours	Allowed: Due to factory delivery, pre-delivery inspection, machine setup and installation of attachments, machines may have hours but should not exceed hour usage guidelines in the warranty administration manual.
Manuals	An operator's manual is included with the delivery of the equipment at no charge.
Miscellaneous	Non-DOT agencies should provide the John Deere dealer with documentation authorizing the agency to use the contract (see Eligibility section). John Deere dealers should upload the following to JD Quote 2: dealer's quote, the agency's PO, agency's authorization to use the co-op program (non-DOT agencies only). ODOT and non-ODOT agencies can order the specific line-item models as shown in the Price Structure below. The line-item mowers will be charged the price indicated in the Price Structure using the price pages that have been hyperlinked below. Agencies can also select mower options different from the line-item options priced below and "build" their own configurations using the price pages linked below. The discount will be applied to the total list price of the new configuration.
