Open Market by Dealer (not listed in the price book)	<p>Allowed: As long as the open market equipment is compatible with the contract equipment being purchased. These open-market items are not available from John Deere but are offered by the delivering Dealer to complete the purchase of John Deere equipment awarded on contract. Examples of open market items/equipment that are not John Deere are service agreements, implements, attachments, accessories, parts, etc.</p> <p><u>Items must be clearly labeled on the purchase order or quote as Open Market.</u></p>
