Quotes	Quotes are valid for 30 days from the creation date of the quote <b>OR</b> until the contract expires, <u>whichever occurs first</u> . All quotes created in JDQ2 have creation and expiration dates on the upper right hand corner of the first quote page for your convenience.

Credit Cards	Credit card usage is optional for purchases up to \$10,000. Credit cards are not accepted for purchases over \$10,000.

<p>Special Delivery Obligations</p>	<p><b><u>Late Delivery</u></b></p> <ul style="list-style-type: none"> <li>○ Must communicate to the ordering agency’s point of contact in writing of any possible delay and then only proceed after receiving written authorization from the order agency.</li> <li>○ When a PO status update is requested, provide an update in writing via e-mail, with any pertinent data, within 24 hours of the request.</li> </ul> <p><b><u>Manuals</u></b></p> <p>Operators manual must be included with each unit at no charge. Parts and Technical manual should be included upon request by the ordering agency. Electronic formatted manuals on CD or online may be supplied in lieu of paper manuals.</p> <p>Dealers will be reimbursed for manuals listed on the quote.</p> <p><b><u>PENNDOT</u></b></p> <p>PENNDOT may require additional items to complete the contract purchase. Those items not included in the price pages should be quoted as Open Market items to complete the sale.</p>		
<p>Fees</p>	<p>A non-taxable, optional delivery charge of \$4 per loaded mile is allowed for the delivering dealer. If charged, the fee must appear on the quote or purchase order. Use <a href="#">Google Maps</a> to calculate the mileage.</p> <p><b><u>Training Fee Allowed</u></b></p> <p>\$100 / Hour for services that go beyond normal commercial delivery and set-up services only. Charge must be itemized and included on quote (prior to PO being issued) otherwise fee may not be charged.</p> <p><b><u>Attachments / Accessories Fee Allowed</u></b></p> <p>\$100 / Hour may be charged to the agency for the installment of attachments and accessories in lieu of the additional set-up allowances (using published MST hours) per the dealer reimbursement schedule. If you opt to charge the agency, the charge must be included on quote (prior to PO being issued) otherwise it may not be charged to the agency.</p>
