<p>Multiple Unit Discount</p>	<p>Multiple unit discounts are allowed. The contract discount plus the multiple unit discount equals the total discount. Discounts are based on the following schedule:</p> <p>3-4 units – 1%</p> <p>5-6 units – 2%</p> <p>7-8 units – 3%</p> <p>9 units or more – 4%</p> <p>Sales of 3 or more like self-propelled products sold on the same purchase order are eligible for the multi-unit discount. Self-propelled products, with the exception of our utility vehicles (provided UV's are on the contract) must be listed in the same tabbed price book section. Compatible implements sold with such products also qualify for the multi-unit discount, but do not count as a unit.</p> <p>Frontier Equipment is excluded from the Multiple Unit Discount.</p>
<p>Non-contract (Deere)</p>	<p>Allowed as long as the equipment is related to and compatible with the contract equipment being purchased.</p> <p>Non-contract Equipment - implements, attachments, accessories, parts or bundles branded by John Deere that are requested by the customer to complete the purchase of John Deere equipment awarded on contract.</p>
<p>Rental</p>	<p>Not allowed on this contract</p>
<p>Substitution</p>	<p>Allowed. If a model listed on the Historical Price Pages is no longer orderable, the State will allow a current model to be quoted using current prices if the following criteria are met:</p> <ol style="list-style-type: none"> 1. The old model is no longer available from the factory. 2. The new model is in the awarded category and is comparable and meets or exceeds the previous model and is acceptable to the buyer. 3. The current Manufacturer's Suggested Retail Price (MSRP) can be verified on the John Deere website – www.johndeere.com using the "Build Your Own" link.
<p>Trade-in</p>	<p>Allowed. Items must be clearly labeled on the purchase order or quote as Trade-in. The agency and the dealer determine the trade-in value.</p>

Delivery Obligations

Quotes within 48 hours.

Hour meter not to exceed 3 hours.

The standard manufacturer warranty shall apply to all models. A properly executed warranty must be delivered with the equipment. For warranty of aftermarket equipment and/or paint, Dealer may utilize a third party warranty to meet this requirement.

Prior to delivery of any equipment, the dealer should make arrangements with the ordering entity for the purpose of scheduling delivery and conducting an inspection of the equipment. All equipment is subject to inspection to establish conformity to specifications prior to acceptance. Equipment shall be ready for immediate operation. Pre-delivery servicing and adjustments shall include, but is not limited to, the manufacturer's recommendations as well as the following:

- A. Complete lubrication of operating chassis, engine, and mechanisms with Manufacturer's recommended grades of lubricants;
- B. Check / Fill all fluids levels to assure proper fill;
- C. Adjust engine(s) /motor(s)/drive(s) to proper operating condition (s);
- D. Check to assure proper operation of all accessories, gauges, lights, and mechanical and hydraulic features;
- E. Inspect electrical, braking and suspension systems, Charge battery;
- F. Inflate tires to optimal pressure;
- G. Fill gas tank(s) with gas and/or alternative fuel up to \$5.00;
- H. Equipment must be clean and thoroughly detailed prior to delivery. Equipment must be delivered free of any decal or other attached item identifying the dealer. The equipment is expected to be completely cleaned and operational at the time of delivery/pickup;
- I. All factory defects must be corrected prior to delivery;
- J. Two (2) pre-tested keys when applicable. The equipment key code must be provided, attached to the keys;
- K. The State, at its discretion, may request installation of State provided decals;

The following items should be delivered with each equipment purchase:

- A. Completed Pre-Delivery Inspection Form
- B. Operators (owners) Manual
- C. Manufacturer's Warranty Information
- D. Dealer Specification Quote (when applicable)
- E. State Supplied Purchase Order
- F. Manufacturer/Dealer Invoice
