

## BuyBoard Grounds Maintenance Equipment, Irrigation Parts, Supplies & Installation Contract

<b>Contract Period:</b>	June 1, 2020 – May 31, 2023
<b>Eligibility:</b>	<p>This contract is available to BuyBoard Texas Cooperative members and BuyBoard National Purchasing Cooperative members. Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local [John Deere Dealer](#). Submit your purchase order to your dealer. The John Deere Dealer will submit the purchase order to John Deere’s Government Sales office.

**All purchase orders must show Deere & Company as the vendor and reference the contract number.**



Machine Hours	<b>Allowed:</b> Due to factory delivery, pre-delivery inspection, machine setup and installation of attachments, machines may have hours but should not exceed hour usage guidelines in the warranty administration manual.										
Manuals	An operator’s manual is included with the delivery of the equipment at no charge.										
Miscellaneous	<p><b>Shipping charges</b></p> <p><b>Alaska (AK) and Hawaii (HI): Shipping charges apply.</b> For deliveries to AK or HI, factory freight to the delivering dealer will be paid by the BuyBoard Member. <u>Factory freight is known at the time of quoting and will be included on the quote to the BuyBoard Member.</u></p> <p><b>Continental US:</b> For all other deliveries within the continental US (excludes AK &amp; HI), the BuyBoard member will NOT be charged factory freight to the delivering dealer.</p> <p>John Deere will be responsible for submitting (email: <a href="mailto:info@buyboard.com">info@buyboard.com</a>) a copy of the agency's purchase order to BuyBoard.</p>										
Multiple Unit Discount	<p>Multiple unit discounts are permitted. The contract discount plus the multiple unit discount equals the total discount. Open Market by Dealer (not	<b>Allowed:</b> As long as the open market equipment is compatible with the contract equipment being purchased. These open-market items are <b>not available from John Deere but are offered</b>										

listed in the price book)	<p><b>by the delivering Dealer</b> to complete the purchase of John Deere equipment awarded on contract. Examples of open market items/equipment that are not John Deere are service agreements, implements, attachments, accessories, parts, etc.</p> <p><u>Items must be clearly labeled on the purchase order or quote as Open Market.</u></p>
