Fees	<p>A delivery fee of \$8.00 per loaded mile is allowed. This fee is <u>not</u> per machine; it's per load. This fee should be shown separately on the quote or purchase order. Miles are to be calculated using Google Maps.</p> <p>Dealers have the option to charge customers 4% of the equipment contract sale for set-up for golf products only (reel mowers, special application mowers, special application vehicles, aeration, debris maintenance, golf fleet management. The 4% set-up is in lieu of any/all Government Sales reimbursement for set-up.
