Purchase orders must be generated by the [Texas SmartBuy \(TSB\) system](#). Only purchase orders issued through the TSB system are eligible for contract pricing. POs issued by the TSB system will have the State of Texas logo at the top and will be signed by Bobby Pounds as shown [here](#). The agency should generate the PO and provide it to the dealer. The John Deere Dealer will submit the purchase order to John Deere's Government Sales office.
